All subcontractors interested in bidding this project for work in excess of \$500,000 must also be prequalified by the State of Connecticut Department of Administrative Services (DAS) for the classification of work that they are bidding at the time of bid.

In addition, in the bidding of most deferred maintenance, major renovation, and new construction projects, contractors are advised they must award (25%) twenty-five percent or more of the value of their awarded contracts to certified SBE's; and, of that amount, twenty-five percent (which amounts to 6.25% of the total award) or more must be awarded to SBE's who are also M/WBE's. The contractors are responsible for ensuring that they and the SBE's they have selected, are eligible contractors and that they meet State requirements.

At the time of bid, Skanska will identify specific bid packages that will be set aside for SBE, MBE and WBE firms only. Subcontractors interested in bidding on these packages must be thus certified by the State of Connecticut DAS Supplier Diversity (Set Aside) Program.
