		<b>Add</b> the following new subsection 1.3 Micro Business (C.G.S.§ 4b-57(c)) from 1212 QBS Submittal Booklet Requirements, Division 6 – Additional Criteria Considerations & MBE Certification:	
		1.3 Micro Business [C.G.S.§ 4b-57(c)]: (ONLY Applicable to On-Call Selections) C.G.S.§4a-59(c) defines a "Micro Business" as a "business with gross revenues not exceeding three million dollars in the most recently completed fiscal year". Insert one (1) copy of your firm's Federal Internal Revenue tax for the most recent fiscal year, behind the Division 6 Tab, to establish the firm as a "Micro Business". Failure to provide such a tax return with your firm's "Submittal Booklet" could deny the firm consideration to receive an additional ten (10) "Micro Business" points. For firms who have not yet filed their tax return for the most recent fiscal year, in lieu of a tax return, a letter from a Certified Public Accountant attesting to the firm's gross revenues for the most recently completed fiscal year will be accepted.	
		If a firm supplies the above documentation establishing that they are a "Micro Business" then the firm shall receive an additional <b>ten (10)</b> "Micro Business" points that shall be applied toward the firm's "Total Selection Grade Points".
