- 1. Ron Zanobi reviewed the Department of Construction Services requirements related to the bidding process, including:
- A. Contact person for future site visits Peter Negrini, Plant Facilities Engineer (860-616-3667).
- B. Reviewed the general scope of work as outlined in the Contract Documents.
- C. Contract Documents are available at the DCS office, 165 Capital Avenue, Hartford, CT.
- D. Bids are due August 20th by 1:00 p.m. at the State Office Building, 165 Capital Avenue, Hartford, CT in Room No. G-36.
- E. Building will be occupied during construction.
- F. Time frame is 60 calendar days.
- G. All questions are to be sent via FAX to the Architect. Deadline for questions is August 12th. Deadline for substitutions is Friday, August 9th.
- H. All workmen are required to check in with security, but a full background check is not required.
- 2. Martin Benassi provided an Agenda which outlined the following items:
 - A. General scope of work including the following items:
 - a. The removal of existing roofing system on low slope areas down to decking; inspection of decking; patch/repair of any damaged or defective areas.
 - b. Inspect existing wood blocking scheduled to remain for soundness and securement to structure; provide additional anchorage as required to comply with FM Global specifications; provide additional wood blocking to match thickness of insulation; verify proper securement of all curbs to decking.
 - c. Installation of a new tapered insulation system, mechanically fastened through protection board to metal decking and adhesively attached to concrete decking; install crickets and saddles to prevent any standing water and provide slope to drains; increase fastening along perimeter and corners of building area with metal decking in compliance with FM Global requirements.
 - d. Installation of a new 2-ply, MBR membrane roofing system over protection board, including all related flashings and terminations. Specified membrane manufacturers include Soprema, Firestone, and Johns Manville. Liquid flashings are also required.
 - e. Provide all new sheet metal including, but not limited to, drip edge, copings, and counter flashing.
 - f. Replacement of roof drains and installation of new overflow scuppers.
 - g. Masonry restoration of chimney.
 - B. Retainage is 7½ %, NOT THE 5% AS NOTED ON THE AGENDA.
 - C. Liquidated Damages as noted.
