**Item 1**

In Section 01 32 16 add the following to paragraph 1.5:

**C. TWO-WEEK LOOK AHEAD SCHEDULES**

The General Contractor shall be required to produce and submit to the Construction Administrator a three week schedule consisting of one week behind the date of the submission depicting work completed, and two weeks look-ahead to be updated and submitted the day of each meeting.

**Item 2**

In Section 01 32 16, Paragraph 1.6.6.2 :

**DELETE:** Paragraph 6.2 regarding weather day allowance

**SUBSTITUTE:** The minimal allowed duration of the Weather Days Allowance shall be 7 calendar days.
