**Item 1**

Question: Will parking be allowed on site or need to park at a local garage?

Response: Only one vendor truck will be allowed on the site

**Item 2**

Question: Can the shutdowns take place during normal working hours or do they need to take place on the weekends?

Response: The shut downs can take place during working hours.

**Item 3**

Question: Is there a UI contact person? UI allowance for utility charges?

Response: No. DAS/DCS has implemented a new method and the contractors are no longer responsible for purchasing the licenses.


**Item 7**
