The apparent lowest qualified bidder is required to submit key supporting documents within fifteen (15) calendar days of the bid opening. If there are any delays in the receipt of these materials then the Bids shall remain valid for the same additional number of days. For example, if the materials are submitted four (4) days later; then the bid shall remain valid for ninety-four (94) days. The Department of Administrative Services, Division of Construction Services may reject a bid as non-responsive if the bidder does not make all required pre-award submittals within the time designated by the Department of Administrative Services, Division of Construction Services.

If written notice of the acceptance of this Bid is provided by mail, facsimile or other communication technology, or delivered to the Undersigned after the bid opening date or any time thereafter before this bid is withdrawn, the Undersigned will, within 10 days after the date of such notice, furnish all documents requested in the Letter of Intent.
