PRICE POSTING DEADLINE NOTE FOR NEW OUT-OF-STATE SHIPPER PERMITS:

Products being shipped to wholesalers or retailers in Connecticut require a recurring price posting, due by the 6th of each month in order to be effective for the following month. If an out-of-state shipper permit is not approved until after the 6th of the month, the permittee will not be able to meet that deadline and will have to wait until the next month. For example, if a permit is issued June 7, the price posting will not be due until July 6 but shipping will not be able to begin until August, regardless of when it is submitted between the license effective date and July 6.
