

**EXHIBIT A**

**DESCRIPTION OF GOODS & SERVICES FOR STREET LEGAL MOTORCYCLES**

**PRODUCT AND/OR SERVICE SPECIFICATIONS:**

The equipment (the "Equipment") ordered through this Contract will be used for the motorcycle safety training classes conducted by the Connecticut Rider Education program.

All Equipment purchased under this Contract must be the latest standard new production model at the time of delivery as evidenced by the manufacturer's then current published catalog or other literature. All Equipment must be the same quality as what is normally supplied to the general public and must conform to all specifications listed. Any attachment and/or other Equipment accessory must be installed in a manner so as not to adversely affect the Equipment in any manner.

Equipment must comply with all applicable Occupational Safety & Health Administration (OSHA), International Organization of Standardization (ISO), and State and Federal regulations and safety standards in force at the time of delivery. All applicable guards, lift arm supports and warning labels required by law must be in place prior to delivery.

**AUTHORIZED DEALER:**

The Contractor shall be an established, authorized distributor/dealer of the Equipment offered and must be capable of performing certified warranty repairs to the Equipment if required.

The Contractor shall remain an authorized distributor/dealer of all Equipment offered for the duration of the Contract. Non-compliance by the Contractor with this requirement permits the Client Agency to terminate the Contract.

**MANUAL:**

The Contractor shall provide the Client Agency the following with each piece of Equipment:

- One (1) Operator's Manual either in print or CD format.
- One (1) Maintenance Manual either in print or CD format.
- One (1) Parts Manual in either print or CD format.

**ENGINE:**

The Equipment engine displacement must be no less than one-hundred fifteen (115) cubic centimeters and no more than two-hundred seventy-five (275) cubic centimeters. There will be no exceptions. All engines shall be four stroke, electric start.

**INSPECTION:**

The Equipment is subject to incoming inspection and testing by the Client Agency prior to being accepted by the Client Agency. In the event that the Equipment is deemed defective or is otherwise found by the Client Agency not to be in conformity with the Contract, the Client Agency shall have the right to either refuse delivery or to require the Equipment's correction prior to acceptance. The Contractor shall be responsible for any and all costs related to this section.

**DEMONSTRATION:**

The Client Agency reserves the right to request a demonstration or make an inspection of any Equipment being offered prior to the Contract award. Contractor shall schedule any demonstration requested to be held within five (5) calendar days of request in the State of Connecticut.

**WARRANTY:**

Contractor shall provide a minimum twelve (12) month manufacturer's warranty. In addition to the manufacturer's warranty, the Contractor shall guarantee any accessories or attachments against faulty workmanship and/or material for a minimum period of twelve (12) months. The Contractor shall make repairs and/or provide replacement of faulty units, assemblies or parts as necessary during the warranty period. All warranty work done and any parts needed related to the work shall be done or provided solely at Contractor cost.

All warranties and guaranties are effective on the date that the Equipment is actually placed into service by the Client Agency. The Client Agency shall notify the Contractor in writing when each piece of Equipment is placed into service.

Contractor shall provide engine warranties from the engine manufacturer for a minimum of two (2) years from the date the piece of Equipment is put into service by the Client Agency. The Client Agency may direct warranty work to be performed at either the Client Agency's assigned location or at a manufacturer's authorized dealership.

Unless otherwise specifically referenced herein, warranty services and parts shall be available within forty-eight (48) hours after notification.

**DELIVERY:**

Contractor shall make each delivery to the location specified on each purchase order. Deliveries must be made between 9:00 a.m. and 3:00 p.m., Monday through Friday. The Contractor shall be responsible for providing a forty-eight (48) hour advance notice for delivery and coordinating delivery arrangements with the Client Agency.

The Contractor shall indicate the best factual delivery date possible where indicated on the Exhibit B Price Schedule.

The Contractor shall be responsible for the delivery of Equipment in first class working condition free on board (FOB) Client Agency designated destination and in accordance with good commercial practices.

The Contractor shall deliver all Equipment completely assembled, serviced, oiled, clean and ready for immediate use.

**PURCHASE ORDERS:**

**CERTIFICATE OF ORIGIN:**

The Contractor shall furnish a certificate of origin to ConnDOT for every vehicle purchased.
