2. All bidders should revise the answer to RFI T under Item #8 in Addendum 5 as follows.

RFIT Question - Please confirm that the new ramp at the south end of the building as shown on A1.11A, detail 8/A6.03 is not included in the scope of work for BP31.1.

Answer – That is NOT correct. This ramp is by BP #31.1 That is correct, this ramp and associated walls shall be furnished and installed by BP #3.1. The capstones shall be furnished installed by BP #4.1. Excavation, prep and backfill is by BP #31.1.

3. **All bidders** should incorporate the following Bid RFI questions with answer as they relate to their bid package scope of work:

RFI A Question – Addendum 5 deleted the Bituminous Dampproofing Specs. from BP #3.1. Who is responsible for the foundation waterproofing?

Answer – Foundation waterproofing and dampproofing as shown on architectural and structural-drawings is the responsibility of BP #3.1.

RFI B Question – In reference to Addendum #5 Item #3 and #4, is the 1958 building considered Higgins Hall in its entirety?

Answer – No. The 1958 building is center portion of the building The 1949 building is to the South and the Annex is to the North. Multiple drawings show the extents but it is best represented on the HM series plans.

RFI C Question – Specification 084413 section 3.4 Field Quality Control: Is testing paid for by the owner or glazing contractor?

Answer – Testing for 084413 will be performed by owner as indicated in 085113.

RFI D Question – Frame type V1: which ones, if any, are rated?

Answer – Please see detail 1/11.02 for V1 frame type.

RFI E Question – Are the display cases included in our bid package 8.1?

Answer – Toilet Plans and elevations showing mirrors are part of specification section 10 28 00 and included in **Bid Package #9.2 General Trades.** Mirrors specified in 088300 are included in **Bid Package #8.1 Aluminum Window Systems**

RFI G Question – We see skylights #1 and #2 between columns 2 & 4 and A & C. References are made to skylight #4 on sheet A4.01. Please advise the location of skylights 3 and 4.

Answer – There are only skylights #1 and #2, please disregard the reference to skylight #4 on sheet A4.01.
