## **Questions and Answers:**

**Question #1:** I am with a company that tracks consultant opportunities and I saw that the Department of Energy and Environmental Protection is accepting applications for grants for pumpout stations and facilities to dispose of boat sewage. May I ask if the grant goes through and this project is funded if you will at that time also publicly seek consultants for the design of these new & rehabilitated pumpout stations?

**Answer #1:** We will not be seeking consultants for the design of these new and rehabilitated pumpout stations. The grantees themselves will be soliciting technical assistance for the work to pumpout facilities, as needed. The DEEP will administer the grants for proposed work to these facilities.
