As a point of clarification, it should be understood that the Contract Documents govern all aspects of the project. Discussions held during the Pre-Bid Conference or over the telephone are informal and informational only. All official changes to the Contract Documents are made only by addenda. The following changes and additional information are hereby made a part of the Contract Documents:

A pre-bid conference was held on July 13, 2018 at 10:00 am. A copy of the Agenda is included as Attachment A and considered a part of this Addendum.

SPECIFICATIONS

- 1. Section 00310, "Bid Form", page 00310-7, Item No. 24, **DELETE** the quantity "6" and **INSERT**, therefore, the new quantity "10".
- 2. Section SC-32 "State Prevailing Wage Rates", **DELETE** the State Wage Rates in their entirety and **INSERT** the updated State Wage Rates included as Attachment B to this Addendum.
- 3. Section SC-34 "Federal Prevailing Wage Rates", **DELETE** the Federal Wage Rates in their entirety and **INSERT** the updated Federal Wage Rates included as Attachment C to this Addendum.
- 4. Section 01150 "Measurement and Payment", page 01150-4, Items No. 2 and 3, paragraph B.1, line 8, immediately following the word "excavation)," **ADD** the following words "for furnishing and installing a concrete mud slab if required,".
- 5. Section 01150 "Measurement and Payment", page 01150-11, Item No. 27, paragraph B, line 7, immediately following the words "pile caps" **ADD** the following words ", bollards, gravel parking restoration,".

DRAWINGS

- 1. Sheet C-1, immediately following Construction Note No. 31, **ADD** new Construction Note No. 32 as follows:
 - "32. All existing vegetation, planting beds, shrubs, hedges, etc. on private property disturbed, damaged, or removed for construction of this project shall be replaced inkind to the satisfaction of the property owner, at no additional cost to the Owner."
- Sheet C-3, ADD a note to the drawing that reads as follows:
 "NOTE: Contractor is hereby notified that numerous small to large trees exist within the easement that will require removing. A Bid Item has been included in the Contract

Documents for this purpose."

- 3. Sheet C-4, in the plan view, **DELETE** the call-out note "Relocate shed to a location on this parcel as directed" and **INSERT**, therefore, the new note "Realignment of the water main in this area will be allowed, as approved, so as to avoid relocating the existing shed".
- 4. Sheet C-4, immediately following Note No. 13, ADD the following new notes:
 - "14. Contractor is hereby notified that numerous small to large trees exist within the easement that will require removing. A Bid Item has been included in the Contract Documents for this purpose.
- 5. Sheet C-6, immediately following Note No. 6, ADD the following new notes:
 - "7. Contractor to remove and reset existing split rail fence on property of #69 Daniel Ave. No separate payment shall be made for this work."
 - "8. Contractor to restore all vegetation disturbed on property of #69 Daniel Ave. No separate payment shall be made for this work."
 - "9. The portion of Daniel Ave. south of the culvert is a private road. All construction shall be limited to the easement on property of #69 Daniel Rd. in this area. Any private roadway disturbed as a result of the Contractor's activities shall be repaired to the satisfaction of the Owner. No separate payment shall be made for this work."
 - "10. Furnish and install 3" concrete mud slab below the pipe bedding, if required, from Sta. 32+10 to Sta. 33+32, and from Sta. 34+13 to Sta. 37+50."
- 6. Sheet C-8, **DELETE** in its entirety and **INSERT**, therefore, the new Sheet C-8 included as Attachment D to this Addendum.
- 7. Sheet C-18, **ADD** the "Bollard Detail" that is included as Attachment E to this addendum.

QUESTIONS AND ANSWERS

Questions from the Contractors received during the pre-bid meeting held on July 13, 2018 and additional comments by the Engineer, and additional questions received:

- 1. *Q:* Where can the existing riprap on Tuttles Point Rd. (Sheet C-8) be stored until reinstalled?
 - A: The riprap can be temporarily stored on a vacant parcel adjacent to the Public Works site at #47 Driveway, or the Town's waste transfer station at 1900 Boston Post Rd.
- 2. *Q:* Can the Contractor store his purchased materials at the Town's yard.
 - A: Yes at #47 Driveway
- 3. *Q*: Does the Contractor off-load the materials if provided by the Owner?
 - A: Yes at the Town yard #47 Driveway (See specification Section 01150 'Measurement and Payment', page 01150-5, paragraph B.1).
- 4. *Q*: Can the Town take the spoils?
 - A: Yes The spoils can be brought to the Town's waste transfer station at 1900 Boston Post Rd.

- 5. *Q*: Are there any environmental concerns turtles, etc.?
 - A: Yes Refer to Sheet C-1, Environmental Considerations notes for requirements and restrictions.
- 6. *Q*: Does the Contractor need to pave daily or only on Friday?
 - A: See Sheet C-1, Construction Note No. 21.
- 7. *Q*: Will steel plates be allowed?
 - A: See Sheet C-1, Construction Note No. 21.
- 8. *Q*: Are the work hours in the Specifications?
 - A: Yes Refer to Section 00800, page 00800-6, paragraph SC 7.02.
- 9. *Q*: Will police be required for traffic?
 - A: No Flagmen will be allowed. There is an Item in the Bid for this.
- 10. *Q:* What permits are outstanding?
 - A: Army Corps of Engineers (General Permit), and CT DEEP (Structures, Dredging, and Fill). Contract will not be awarded until all permits have been acquired.
- 11. *Q:* Will the CT Water Co.'s price for materials be revealed?
 - A: No The CT Water Co.'s material procurement process precludes this. The award of the Contract is based on the Base Bid.
- 12. Engineer Comment: Pre-Bid Conference agenda Item No. 3, 5th bullet, **DELETE** the number "173" and **INSERT**, therefore, the new number "175".

- Installation of water main and appurtenances, and surface restoration;
- Installation of an elevated water main on helical piles;
- Installation of water main in the vicinity or within an existing corduroy (log) base road;
- Work within wetlands and the upland review area in particular, an intermittent stream crossing shown on Sheet C-4;
- Installation of 173 water services up to and including the curb stop at the property line;
- Work within easements.
- 4. There has been no addendum issued to date. An addendum will be issued following this meeting and will include the minutes of the pre-bid meeting, and responses to all RFI's to date. Bidder is responsible to make sure he receives all addendums issued. The deadline to receive questions is Thursday, July 19, 2018, at 4:00 PM local time.

- 7. The contract, if awarded, will be awarded to the bidder whose Bid is in the best interest of the Owner. Performance and Payment Bonds and Insurance Certificates must then be submitted for approval by the Owner before the Notice to Proceed is issued.

- 8. If the Successful Bidder fails to execute and deliver the Contract Documents and furnish the required contract security within 15 days after the Notice of Award, the Owner may annul the Notice of Award and the bid security of that bidder will be forfeited.
- 9. Prospective bidders should familiarize themselves with coordination requirements pertaining to the organizations listed below. Refer to Section 01050.
 - a. The Connecticut Water Company
 - b. Town of Guilford Public Works Department
 - c. Eversource Electric

- 10. The Contractor is responsible for obtaining laydown areas.
- 11. There will be a full-time Resident Project Representative on-site during construction.
- 12. The Owner will employ an Independent Material Testing Company. Refer to Section 01400.
- 13. There will be 390 days for Substantial Completion and 450 days for Final Completion.
- 14. In the preparation of Drawings and Specifications, Engineer relied upon the following drawings and field information:
 - a. Plans provided by the Town of Guilford.
 - b. Survey provided by Martinez Couch and Associates.
 - c. Survey provided by Criscuolo Engineering, LLC.
 - d. Supplemental limited field edit observations and measurements.
- 15. Bids will only be accepted from those who are on record as having bought a complete set of Bidding Documents through the Wright-Pierce online plan room.
- 16. A copy of the latest list of Plan and Specification holders is available at the online plan room.
- 17. Refer to the General Notes on the plan sheets for requirements that may not be indicated in the specifications.
- 18. The Contractor is responsible for verifying all dimensions required for the layout of the new work.

- 20. Partial list of additional project requirements:
 - a. This is a CT DPH funded project. There is required record keeping by both the Owner and the Contractor (AIS requirements, wage certification, MBE/WBE requirements, etc.). The Contractor will be required to respond without delay to any requests by the Owner regarding these matters.
 - b. The new water system will be managed by the CT Water Co. (CWC). The Contractor will be required to strictly adhere to CWC's requirements regarding materials installed. The CWC requirements are included as an appendix to the Specifications.
 - c. It is the Bidder's responsibility to verify with the CWC whether they are on CWC's list of prequalified contractors. Any Bidder not on the list must submit with his/her Bid a CWC prequalification package forms are provided in an appendix of the Specifications. Any Bidder not on the CWC current list, or has not submitted a prequalification package with his/her Bid, may be deemed an unqualified Bidder.
 - d. The Contractor shall adhere to the CT Water Co. requirements regarding CAD survey project digital as-builts (requirements included as an appendix to the Specifications).
 - e. Proposed water service locations have not been shown on the plans. Locations to be determined during construction by the Owner and the CT Water Co. Existing well and septic location sketches will be made available to the Contractor during construction.
 - f. Bidders are directed to the Environmental Considerations Notes on Sheet C-1 as information contained in these notes impact construction schedules.
 - g. Bidders are directed to Section 00800 Supplementary Conditions paragraph SC-7.08 'Permits' of the Specifications. The Owner is in a process of obtaining the listed permits/approvals/applications for the project. The award of the project is contingent upon the Owner obtaining <u>all</u> required Local, State and Federal permits for the project. Copies of the permits will be on file at the Owner's Offices. It is the responsibility of the Contractor to be familiar with the applicable provisions of each permit as they apply to the work.
 - h. The Bid Form contains a Bid Add Alternate item. This item includes the providing of all ductile iron pipe, fittings, mega-lugs, gate valves and boxes. Award of contract will be based on the total Base Bid in other words, excluding the Bid Add Alternate item.

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than "SU" or "UAVG" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the "SU" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour Regional Office for the area in which the survey was conducted because those Regional Offices have responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:


