Demo Plan, 3/A1.3 Demo Note 5 refers to "Remove existing plumbing fixtures refer to plumbing drawings". Construction Plan, 4/A1.3 Wall Type 5 refers to new wall construction.

item 2:

CLARIFICATION: Drawing No A1.6 Exterior Stairs & Ramp Building 2 - Commissary:

The existing topographic information has been shown on the Demo Plan @ Lower Level Building 2 Commissary & Exterior Stairs and Ramp Plans.

The top of the new ramp, new stairs and retaining walls are all at the same height, 6" above the finish grade.

New guardrails are only required as shown, Refer to Construction Key Note 7

<u>Item 3:</u>

CLARIFICATION: Drawing No A6.7 Stair Elevations & Details:

Install interior handrails and guardrails per Details 9/A6.7, 10/A6.7 & 11/A6.7 on Drawing A6.7 and per the current state building code. Refer to Stair Plans - Drawings A6.1, A6.2 & A6.3

Drawing No A6.2, Stair / Ramp Plans Building 3 - West Domicile:

DELETE: Stair Plan Detail 8/A6.2

Item 5:

CLARIFICATION: Drawing No A12.1 Finish Schedule & Legend Building 2 - Commissary:

A Finish Schedule has been included for the renovated bathroom areas of Building 2 Commissary. All other disturbed areas are to be patched per the Contract Specifications and Contract Documents. In Section 09 67 23 Resinous Flooring - Paragraph 3.3 System Installation - Typical & Paragraph 3.4 System Installation - Stairs add the following:

These resinous flooring systems are to be installed at all new interior ramps / stairs & associated landings for the East and West Connectors.

These resinous flooring systems are to be installed at all new interior ramps & associated landings.

These systems are designed to be used as a non-slip surfacing material for accessibility.

Drawing No A2.2 East Connector Plans & Sections & Drawing No A2.3 West Connector Plans & Sections. Section 09 67 23 Resinous Flooring - Paragraph 3.3 System Installation - Typical, Section 03 30 00 Cast-In-**Place Concrete**

Existing concrete ramp and landing surfaces will need to be prepped in accordance with Part 3 - Execution, 3.1 Preparation. Any areas requiring Cast-In Place Concrete will require the specified 4000 lb psi concrete w/ ¾" stone. Any areas with minimal depth concrete areas will need to be submitted per Paragraph 1.3, Action Submittals of Section 03 30 00 Cast-In-Place Concrete.
