

### **SPECIFICATIONS**

- 1. **DELETE** Section 01546, Use of Explosives, in its entirety.
- 2. Section 02444, Aluminum Fence and Gates, **DELETE** "2 Channel" and **REPLACE** with "3 Channel" in Item 3.2.B.1.b.i.

### **DRAWINGS**

- 1. **DELETE** the callout "6' HIGH BLACK ALUMINUM FENCE..." and **REPLACE** with "5' HIGH BLACK ALUMINUM FENCE...".
- 2. **ADD** the following detail to DWG C-4 for roadway paving requirements. In addition, refer to Specifications Section 02513, Bituminous Concrete Paving.

## **QUESTIONS**

Question 1: Drawing C-2 Demolition Note #4 – Remove and Demolish existing asphalt. Refer to

Pavement Details on C-4. There are only pavement trenching details shown on this

drawing. Please provide pavement detail.

A pavement detail has been added by and is included in this addendum. Answer:

Question 2: Will building permit fees be waived?

Answer: Actual fees by the Town for the building permit will be paid by the Owner. See

Specifications section 00800, Item 7.08.B for additional information.

Question 3: Who is responsible for independent testing fees?

Answer: Independent testing fees are outlined in Specifications Section 01400. Initial testing is

paid for by the Owner. Certain instances where the Contractor is required to retest or requests to conduct additional testing for convenience will be paid for by the Contractor.

Question 4: Is there an existing bypass connection?

Answer: No.

**Ouestion 5:** Who is responsible for electrical usage fees during bypass pumping and construction?

Answer:

The Contractor. See Specifications section 01500, for additional information on limits of responsibility for temporary facilities. In general, the Contractor will only be responsible for electric usage above and beyond what is considered typical at the station. However, for bidding purposes and since this number is not known at this time, assume that all

electricity costs for the bypass pumps are the responsibility of the Contractor.

In reference to section 01546 there known ledge present. How shall the GC quantify the extent? Can you add a bid item for rock/ledge removal? Question 6:

Specifications Section 01546 has been removed from the contract. Blasting will not be Answer:

> allowed on this project. Most of the excavation work required is within the limits of the original construction. An allowance of 10-CY of ledge removal via hammering is included in the lump sum base bid price. The boring conducted during design was outside of these limits. A separate bid item will not be added. Ledge over 10-CY will be

handled via a change order.

Question 7: In reference to section 03420, who is responsible for providing water for leakage

testing?

Answer: The Contractor. Please note there is no city water service available on the project site.

Question 8: Please advise if blasting will acceptable on this project?
