| Question 4: | On A4 the documents detail a metal cage enclosure. Is there a preferred manufacturer or a specification for the item? | | |

| Question 5: | On A4 the documents detail Bid Alternate for the batt insulation in the ceiling. Is there a specific R value for the insulation? What should the Alternate number be for this option? | | |

| Question 6: | The documents detail on A4 that existing trolley beam w/ new hoist. Is this part of the project and if so there is no equipment list or hoisting specification. Please provide? | | |



| <i>Question 33:</i> Answer: | <i>Could you clarify the scope for each of the alternates?</i> Alternate work is Not In Contract. |
| Question 34: | The finish schedule on drawing A-4 does not call for interior paint, is there no interior paint for the new drywall partitions? |

| Question 35: | Am I correct to assume, the generator pad as shown on drawing E-1, is not part of this contract? |

| Question 53: | It was mentioned at the pre-bid meeting that there may be revisions to the plans and specifications. Please advise if these will be released. |

| Question 54: | For the base bid, no ceiling finishes are shown on the schedule. The detail for Wall Type 1 on sheet A1 shows a ''lay in ceiling or gypsum ceiling see room finish schedule.'' Please confirm what/where, if any, ceiling finishes are to be included in the base bid. |
| Answer: | No ceiling work included in contract. |
| Question 55: | 1-A.4 call out "Existing Hoistway Beam & Trolley w/ new lifting accessories. See Specs for details." We don't see a spec section for this. What, if anything, is to be included? |


