THE PROPOSED WORK CONSISTS OF REMOVING THE EXISTING EPDM ROOF AND INSTALLING A NEW EPDM ROOF.

A MANDATORY SITE WALK WILL BE HELD AT 10:00 AM ON MARCH 27, 2019.

EACH BID MUST BE ACCOMPANIED BY BID SECURITY IN THE FORM OF A CERTIFIED CHECK OR BID BOND, IN AN AMOUNT EQUAL TO FIVE PERCENT OF THE AMOUNT BID. BID SECURITY SHALL BE MADE PAYABLE TO THE TOWN OF WINDHAM AND SHALL BE PROPERLY EXECUTED BY THE BIDDER.

AT THE TIME OF CONTRACT SIGNAGE, SEPARATE 100 PERCENT PERFORMANCE AND 100 PERCENT PAYMENT BONDS WILL BE PROVIDED TO THE TOWN OF WINDHAM.
