### **GENERAL CONDITIONS ITEMS**

- 1. Change all reference to Substantial Completion from August 30, 2019 to October 31, 2019.
- 2. The bid due date is to be revised to <u>July 11, 2019</u>. See attached revised Invitation to Bid.

### **GENERAL SCOPE ITEMS**

- 1. The Contractor shall provide concrete patching, sub-floor preparations, and new VCT floor, to match existing conditions, in the two locations of demolished floor electrical devices as indicated by keynote #9 on drawing 3/E-1.1.
- 2. The Contractor shall remove, and dispose of, the wall mounted mirror adjacent the "existing wall mounted television" indicated on drawing 3/A-1.1.
- 3. The Contractor is to provide new VCT flooring tiles, to match existing, in all areas of removed casework and appliances. All floor tiles that are damaged, punctured, or discolored will be required to be replaced. Color to match existing to remain.
- 4. The Contractor is to provide infill of holes, smoothing of rough surfacing, and prime and paint finish in location of removed casework within the adjacent classroom (North end of exterior casework being demolished).
- 5. The Contractor is to prime and paint all wall and gypsum ceiling surfaces within scope area. Prime and paint the new gypsum partition in the adjacent classroom to match the existing color and sheen. Coordinate color selections with owner.
- 6. The Contractor is to provide epoxy paint (color black), to a height of 4" above the floor, at both masonry returns on corridor side of Toilet #100 to match the existing corridor wall base.
- 7. The Contractor is to provide a new coated metal hydronic radiation cover along the exterior wall north of the new casework installations. Provide trim pieces as it terminates against the new partition and an end cap when it terminates within the existing classroom.

- 8. The Contractor is to provide patching of all wall surfaces where existing casework was removed. All surfaces are to be made flush and uniform prior to any new painting activities.
- 9. The new classroom demising wall shall extend to the underside of the structural deck above with all perimeters caulked with acoustical sealant.
- 10. The new masonry wall above door #100A shall be extended to the structural deck above with all penetrations and perimeter edges sealed with fire caulk. This wall assembly is to carry a 1-hour fire rating.
