Description: **Grade and Pave Sunset Lane in Andover, CT**

Sealed Bids for Grade and Pave Sunset Lane in Andover, CT must be received by **the Town Administrators office, 17 School Rd Andover CT 06232 by 2:00 pm local time on August 22, 2019.**

A pre-bid review of the site will be held at **7 am** local time on **August 8**, at the **Intersection of Sunset Lane and Lake Rd. Attendance at the pre-bid conference is recommended unless there is previous communication with the Town Administrators office.**

Scope of work: Provide services to grade, compact and pave Sunset Lane in Andover.

1. Sunset Lane pavement shall be 255' of 18' wide pavement,
2. 260' of curbing along one side only (the southwest side).
3. Curbing will be cape cod curbing (installed on the first course)
4. Also provide 5 paved aprons 2" thick, approximately 6' x 12' each.
5. Existing pavement at the intersection with Lake Road will require a clean saw-cut (27').
6. Minimum of 4" of processed gravel (1 1/4" minus) for finish grading, compacted.
7. Hot rolled Asphalt shall be applied in 2 courses.
8. 1 1/2" binder course – Minimum Final Thickness.
9. 1 1/2" wearing course. (Class 2)- Minimum Final Thickness.

Contractor shall provide all preparation grading, traffic control and incidentals as necessary.

Bid Requirements

- The successful bidder will be required to provide a performance bond equal to 100% of the Bid amount.
- All Contract documents must certify affirmative action on the part of all contractor and subcontractors to insure equal employment opportunities
- The Contractor is exempt from payment of Sales and Use Taxes on all materials and equipment used on this project. These taxes shall not be included in the Bid.
- The contractor must file a written non-discrimination certification with the town of Andover.

- The contractor must show proof of insurance including General liability and Workman's compensation.
- The contractor must file a written non-discrimination certification with the town of Andover.
- Bids may be withdrawn prior to the opening of bids. After opening Bids may not be withdrawn for 60 days.
- Bid should include the following information: Name, address and description of firm, description of similar projects completed by the firm in the last five years including client contact name and phone number, fee structure, additional information not included above which you feel may be useful and applicable to this project.

The town of Andover reserves the right, as its sole jurisdiction to reject any or all bids, to waive all informality's or defects of a bid or to accept any bid that in the judgement of the town of Andover will be in its best interest. End of Bid Invitation
