 - 1. The project will be funded with municipal funds.
 - 2. As indicated in the Contract Documents, a Bid Bond will be required to be submitted with the Bid.
 - 3. As indicated in the Contract Documents, Performance and Payment Bonds will be required to be furnished.
 - 4. The project is not subject to State of Connecticut Prevailing Wage law requirements.
 - 5. As indicated in the Contract Documents, the date and time for submission of Bids is Monday, August 26, 2019 at 2:00 p.m.
 - 6. Bidders should note the anticipated project schedule for the Base Bid Work outlined in Technical Specification Section 32 00 80 Irrigation Part 1 General, Paragraph 1.01 Project Introduction and Requirements of the Contract Documents.
 - 7. As indicated in the Contract Documents, the Base Bid Work includes the installation of the full length of the mainline piping and all isolation, zone and quick coupling valves for the entire irrigation system, and the irrigation systems for the two Little League Fields identified as Baseball Field No. 1 and Baseball Field No. 2 on the Drawings.
 - 8. As I indicated in the Contract Documents, the existing irrigation system rotary sprinklers located at the two Little League Baseball fields and the PVC lateral piping shall remain in use. All electronic zone valves for these systems shall be replaced and the existing valve boxes shall be reset as part of the Base Bid Work.
