The following Request for Proposal (RFP) questions, answers and clarifications are provided to those who have received the Connecticut General Assembly's RFP for the above referenced Request for Proposal.

The CGA reserves the right to reject any proposal responses received after the above referenced date.
- 2. Is there a listing of what is to be submitted with the responses?

Part D of the Request For Proposal includes a list of required elements that shall be included in all responses. Any response not including these elements is subject to disgualification.

3. Can the CGA please publish the sign-in sheet for the attendees who attended the question and answer meeting?

Yes, please see Attachment I.

4. Is a bid bond required to be submitted with the proposal?

No, a bid bond is not required.

5. Are financials to be submitted with the proposal?

No, vendors shall submit financials during the evaluation period only upon CGA request.

6. Is this scope in anyway different from the scope of work that has been performed in the past?

No, it is almost identical to previous scopes of work from the past.

7. Is the CGA looking to make a change because of quality of work being performed?

No, the most recent contract expired on December 31, 2019.

8. What is the expected contract term?

The contract will be for five years with an option to extend up to an additional five years per mutual agreement.

9. How many points of connection are in the irrigation system?

Three.

10. The flowers budget is listed to be \$30K. Does that fluctuate?

It is the estimated budget, but it is likely to fluctuate year to year.

11. Has the CGA annually used the full 400 yards of mulch in the past?

Yes, but the CGA would like to use less mulch in the future if possible.

12. Are there booster pumps in the irrigation system?

No.

13. Is there a weekly walkthrough between the vendor and CGA?

Yes. The walkthrough will be with one of the managers working for the CGA's facility contractor.

14. Who was the most recent contract with?

Beebe Landscaping Services, Inc.

15. Do base services under the contract include extensive tree work?

No, the awarded respondent shall submit for CGA approval a proposal and quote for any extensive tree work that is above and beyond tree work specified in the RFP specifications. Such work will be billed as time, equipment and materials. The awarded respondent shall have a properly licensed arborist on staff or utilize a properly licensed arborist as a subcontractor.

16. Are there any special considerations to specific areas on the grounds?


There are several rain gardens on the Capitol grounds. The CGA would like the awarded respondent to maintain all current native plants located within the rain gardens.

For hedge trimming on the outside terrace walkway from the LOB to the Capitol, the awarded respondent must use OSHA approved safety harnesses and tethers.

The awarded respondent will be responsible for maintaining Minuteman Park and all its plantings.

17. Where is the divide between the Capitol Grounds and Bushnell Park?

The City of Hartford is responsible for maintaining Bushnell Park starting from the north end parking area except for the area highlighted in red below in which the awarded vendor will be responsible to maintain.



18. Please provide us with the detailed chronological calendar of landscape maintenance and irrigation activities provided by the previous awarded contractor. (Page 2 item B.1.1. d)

Yes, please see Attachment II.

19. Please provide us with the annual report for tree and shrub maintenance, listing conditions of trees and shrubs and outlining all work required and recommended. (Page 3 B.1.4 Tree and shrub maintenance)

The previous vendor submitted itemized proposals for required work on the trees and shrubs which lists the condition. Typically, one in the spring and additional proposals following severe storms.

20. Please provide us with a copy of the proposal of submitted pricing for flower beds and formal landscaping. (B.1.5 Flower beds and format landscaping (item I))

Please see Attachment III.

21. Please provide us with color and type of mulch to be used on property. (B.1.8 Mulching)

Mulch (natural in color) was approved based on a submitted sample.

22. Please provide a copy of the Integrated Pest Management program, submitted by the previously awarded contractor. As well as the monthly written inspection reports submitted by the previously awarded contractor. (Page 7 Item B.1.10 IPM Program and Inspections) (Item C&D) (Attachment H Section 1(e))

The previous vendor stated that they would follow the Integrated Pest Management attachment in the RFP and any modifications per request during the contract period.

23. Please provide a written report of all routine inspection of all trees, shrubs and miscellaneous plant material that was submitted monthly. (page 8 B.1.13 Item a)

The previous vendor submitted itemized proposals for required work.

24. What type/brand of irrigation clocks are used? Can they be controlled from Smart Phones?

The irrigation time clocks at the Legislative Office Building, Minuteman Park, and the two at the Capitol are all Hunter Pro - C, Model PC - 300. The Old State House irrigation time clock is an Irritrol RD-1200 (Rain Dial). They are not controllable from a smart phone.

25. The scope states that no insect control, weed control, or fungicide is included in the base contract. So any control products applied would be a "curative" control rather than preventative? And would be billed as an extra based on SQFT pricing?

Any application of insect control, weed control, or fungicide is to be curative as opposed to preventative and billable based on proposed square foot unit pricing under on-call services on the Proposal Pricing Page.

26. The scope states that 2 pre-emergents fertilizer application are to be applied. One in the spring and one in the fall. Is this correct?

Yes, please see section B.1.3(c).

27. The maps provided to determine annual plantings and quantities seems to have some beds that have perennials and trees. Is this correct? If not correct, are these to be planted with the plants listed in the maps?

The sketches included in the RFP are an example of the plantings in place. There are trees and perennials in some of the beds.

28. Who determines the variety of flowers to be planted to annual beds?

The awarded respondent will submit a proposal which the CGA will approve or will request proposed varieties be modified.

29. How many rotations of annuals are planted? Example, early spring (pansies), summer (petunias, begonias, impatiens), fall (mums, cabbage).

Last year, three proposals (spring, summer and fall) were received for plantings including annuals. Please see Attachment III.
