Is the estimated electrical load for the new equipment feed from panel LP5 available? Has the voltage drop on 600' +/- panel feeder been calculated?

Answer:

The panelboard will be used to supply the new bus wash system provided under a different contract. The exact loads are not known at this time but 180kVA load was used for basis of design. Voltage drop calculation was performed and the conductor sizing indicated on the drawing is reflective of the calculations results.






