# ALL ITEMS:

THE CONTRACTOR SHALL NOT BEGIN WORK ON ANY ITEM SPECIFIED PRIOR TO SECURING A PERMIT FROM THE TOWN OF ENFIELD, BUILDING DEPARMENT. ALL NEW WORK SHALL CONFORM TO THE CONNECTICUT STATE BUILDING CODE (ICC INTERNATIONAL RESIDENTIAL CODE, 2009 AS AMENDED AKA THE CODE.

ALL WORKMANSHIP AND CONSTRUCTION SHALL CONFORM TO APPLICABLE CODES, MANUFACTURER'S RECOMMENDATIONS AND INDUSTRY BUILDING PRACTICES IN ORDER TO COMPLETE ALL WORK AS INTENDED BY THE CONTRACT. THE CONTRACTOR SHALL INCLUDE ALL PERMIT FEES IN THE BID PRICE FOR THE WORK SPECIFICATIONS.

# ALL REFERENCES AND WORK PERFORMED SHALL CONFORM TO THE GENERAL SPECIFICATIONS [SEE INDEX] ATTENTION PROSPECTIVE BIDDERS.

# [ROOFING LEAK]

 The contractor shall inspect and assess all perimeter components including the vent cap, flashing, shingles and caulking at leaking roof exhaust vent/duct which services the kitchen stove discharge/exhaust fan. Ensure flashing and shingles are properly installed and weather-tight at all perimeter points of the roof venting duct. Thereafter, apply 100% silicone/all waterproof flashing cement/roof sealant with long term elastomeric properties to stop the infiltration of roof water entering the house. Product shall be by APOC 122 DURA-FLASH, HENRY, DAP or approved equal by the (OCD). Color of sealant to match the existing shingles as closely as possible. All required roofing work and sealant application per the manufacture's specifications; completed in a neat and workmanlike manner.

2. Thereafter, the contractor shall reconnect the preexisting vent hood using screws to ensure a tight fit. Caulk perimeter and/or around seams of the vent hood connection. Install the preexisting fan and filter; light if included. Have **electrician** attach all preexisting wiring, following the color coding and secure it under the electrical component cover. Plug in the vent hood, turn it on and make sure the vent works. Verify there are no leaks in the duct connection system and make sure that the stove exhaust fan is functional via the roof duct/vent. All work in accordance with the **Building Code** and accomplished in a neat and workmanlike manner.

 Remove sheetrock covering the preexisting meter box opening and thereafter inspect and assess condition of the entire surface(s). Check opening for defects, damage and water infiltration. Thoroughly clean area of mold/mildew and thereafter cover exposed opening with siding to match existing and/or other approved covering per the approval of the (OCD) and owner. Siding/covering to match existing as closely as possible. Thereafter, caulk per manufactures specifications all seams or openings to the elements with 100% waterproofing and weatherproofing Silicone Sealant; minimum grade guaranteed for 25 years. Product by DAP, GE, Titebond or approved equal by the (OCD). All work accomplished in a neat and workmanlike manner.
