THE PROPOSED WORK CONSISTS OF CONSTRUCTING AND RECONSTRUCTING APPROXIMATELY 4,600 LINEAR FEET OF SIDEWALKS.

IF A FIRM WANTS HARD COPIES THEY WILL BE CHARGED A \$50.00 DOLLAR NON- REFUNDABLE FEE FOR EACH SET OF CONTRACT DOCUMENTS OBTAINED. CONTRACT DOCUMENTS WILL BE MAILED UPON RECEIPT OF A NON- REFUNDABLE \$20.00 MAILING FEE .

EACH BID MUST BE ACCOMPANIED BY BID SECURITY IN THE FORM OF A CERTIFIED CHECK OR BID BOND, IN AN AMOUNT EQUAL TO FIVE PERCENT OF THE AMOUNT BID. BID SECURITY SHALL BE MADE PAYABLE TO THE TOWN OF WINDHAM AND SHALL BE PROPERLY EXECUTED BY THE BIDDER.

AT THE TIME OF CONTRACT SIGNAGE, SEPARATE 100 PERCENT PERFORMANCE AND 100 PERCENT PAYMENT BONDS WILL BE PROVIDED TO THE TOWN OF WINDHAM.
