Note: The goal of this bid package is to engage a surveying company to provide on-call surveying work as requested by the Construction Manager's jobsite staff for the John F Kennedy Middle School Addition and Renovations project located in Enfield, Connecticut. The successful proposing firm will provide sufficient manpower to accommodate the surveying needs of the project. The surveying needs will include establishing permanent control, columns lines in two (2) directions, permanent offset marks, and providing a drawing where markers are related to the Building structure and column lines. Gilbane Building Company is the Construction Manager and will be the contracting entity for this Work.

John F Kennedy Middle School Addition and Renovations is a Renovate-to-New status with the State of Connecticut and will encompass a full "like-new" renovation of the existing building and all of its MEP systems.

- Project Start is May 2020 with substantial completion in August 2022.
- Applicable Connecticut Sales and Use taxes for a tax exempt new construction project in accordance with the rules and regulations of the State of Connecticut.
- The surveyor contractor shall possess the necessary licenses and certifications to perform this service.

Provide five (5) references for building projects completed in the last five (5) years where your firm established or verified the following: permanent control, column lines, benchmarks, steel plumbness, anchor bolt survey, etc. Provide project name, location, and contact name and phone number of the General Contractor/ Construction Manager overseeing the project.

Provide a copy of your quality control plan/ assurance plan.

The Surveying firm shall furnish Gilbane with an appropriate certificate which identifies Surveying firm's Professional Liability Insurance Coverage, stipulating not less than a \$1,000,000 limit of liability and a maximum deductible of \$100,000. A copy of said policy will be provided to Gilbane upon its request.

The successful bidder shall supply an insurance certificate for the Project in accordance with Article 3 of the sample Short Form Contract Agreement and Section 00 73 16.2 CCIP Manual.

Each insurance certificate must contain the following conditions on the certificate.

- A. GILBANE BUILDING COMPANY, GILBANE INC, THE TOWN OF ENFIELD AND JCJ ARCHITECTURE ARE TO BE NAMED AS AN "ADDITIONAL INSURED" ON A PRIMARY, NON CONTRIBUTING BASIS ON THE GENERAL LIABILITY (premises and completed operations), AUTOMOBILE AND UMBRELLA POLICIES.
- B. WAIVER OF SUBROGATION IN FAVOR OF GILBANE BUILDING COMPANY AND THE OWNER APPLIES TO ALL POLICIES.
- C. GENERAL LIABILITY GENERAL AGGREGATE IS PER PROJECT.

The successful surveying firm will receive an allowance type contract for satisfactory completion of the surveying services required by the Project. The actual amount due shall be based on the actual services requested by the Gilbane and provided by the surveying firm at the rates listed above. The surveying firm shall not exceed the estimated amount of the contract without prior written authorization from Gilbane. Gilbane reserves the right to terminate the services at any time without penalty. In the event of such termination, the surveying firm shall be reimbursed for the services provided up to the date of termination only.

The undersigned represents that this Proposal is made in good faith, without fraud, collusion, or connection of any kind with any other proposing firm of the same work, that he is competing in his own interest and in his own behalf, without connection of obligation to any undisclosed person, that no other person has any interest in regard to all conditions pertaining to the Work and in regard to the place where it is to be done, has made his own examination and estimates and from them makes this Proposal.
