Sealed bids for furnishing and installing **New Floor Covering at the McGee Middle School Media Center** to the BPS shall be submitted to the Director of Business Operations, Berlin Public Schools, 238 Kensington Road, Berlin, CT, 06037, **no later than 2:00 PM (EST) on July 7, 2020.**

General Conditions and Instructions to Vendors

- A. Bids are to be sealed and placed in an envelope marked **Media Center Floor Covering/McGee Middle School, Bid #B2018-02**. The name and address of the vendor should appear on the upper left-hand corner. Any bid not so marked is subject to rejection. The bid specifications for the floor covering desired are listed below in Schedule A.
- B. All prices bid shall include the complete cost of the merchandize as well as the delivery to and installation at the McGee Middle School, 899 Norton Road, Berlin, Connecticut. Please note that all purchases made by BPS are exempt from sales tax.
- C. No amendment to or withdrawals of bids received later than the time and date specified will be considered. Bids received later than the time and date specified will not be considered. All bid prices shall be valid for a minimum period of 30 days after bid date. It is necessary to bid on all items listed to be considered.
- D. The BPS reserves the right to reject any and all bids in part or in whole, and to award the contract other than to the lowest vendor upon a determination by the Superintendent that such action is in the best interest of the BPS.
- F. This bid is signed by the vendor with full knowledge of the specifications and all itemizations, qualifications, etc., and if accepted will be made a part of a subsequent contract to purchase.
- G. It is understood and agreed that the signing of this bid embraces all of the conditions and requirements of the Invitation to Bid.
- H. The bidder shall include written information regarding the bidder's past experience and qualifications related to its ability and capacity to perform the work required, including information regarding its work with other school districts.

- I. Bids will be opened in public and read aloud directly following the submission deadline at the Berlin Public School Offices. Within a reasonable time following the bid opening, the bids will be tabulated and analyzed, and awarded to the lowest responsible qualified bidder, subject to the right of rejection. Following award, all bidders will be notified in writing whether they were selected.
