As of 27 June 2011, SAIC received its final payment on the subject contract for that portion of work completed by SAIC. In accordance with the memorandum negotiated in February 2011 (Reference Connecticut Department of Motor Vehicles Grants and Contracts Contract File Memorandum dated 11 February 2011 from Andy Munson, Division Manager), SAIC amended Subcontract Agreement No. P010032005 with 3M to reflect the transition of lead organization from SAIC to 3M. As such, between 3M and SAIC, 3M acknowledged assumption of full authority and responsibility as Project lead working directly with the State to complete the Project. With the receipt of its final payment from the State of Connecticut, SAIC hereby transfers to 3M the right and responsibility to prepare, submit, and receive payment on any future invoices with the State for direct reimbursement.

SAIC, however, acknowledges that it will remain primarily responsible for the completion of the terms and conditions of the Agreement. Any enforcement of the terms and conditions of the Agreement will be made in accordance with the terms of the Agreement with SAIC which remains fully responsible for the performance of its subcontractors and the completion of the project. This memorandum serves as an acknowledgement that all future payments may be made by the State directly to 3M, and that 3M has been installed as the point of contact for the State regarding system development and deliverables.
